

Rationale

The OSGA (Ontario Senior Games Association) has a mandate to seek opportunities to support those areas that encourage active living as set out in its 55+ senior games programs. The OSGA will offer support, particularly to regions through its personnel, its expertise, its established programs, and through financial assistance at times when funding is available. The purpose of this policy is to guide the OSGA in providing funding to any Regions planning sets of games in Ontario. To this end, the following will guide the OSGA.

Policy Guidelines

1. Regional GOC's requesting funding support will:
 - a. Be a recognized 55+ Games Region in Ontario;
 - b. Have formed a functioning Games Operating Committee (GOC) including a Chair, Treasurer, Secretary, Event Chair, Administration Chair ;
 - c. Have opened a bank account for the purposes of operating a set of Regional Games;
2. Regional GOC's will submit the form in Appendix A to the OSGA office:
 - a. indicating the events (minimum of 10+ traditional + 2 other) it plans to offer which will include:
 - i. Selected games from the OSGA Technical Manual; and
 - ii. Other events peculiar to communities within the region;
 - b. Including an indication of the amount requested and a brief outline of the planned use of such funds
 - c. including a draft budget
3. Funds will be distributed in two (2) installments.
 - a. First installment (80%) upon approval of application
 - b. Second installment (20%) June 15th
4. Regional GOC's will give appropriate recognition to the OSGA for the funding through:
 - a. Sign displays
 - b. Inclusion in printed publications
6. Regional GOC's agree to and complete the following OSGA reports within 45 days of the end of their Games:
 - c. A final financial report;
 - d. A statistical report of Regional Games including numbers in each event, medal recipients, number of volunteers,
 - e. An indication of distribution of any legacies.

Administration

This policy shall be administered by the OSGA President and Regional Games .
