CARRIED Motion: by Ellen Paterson (27) seconded by Nickie Sloan (2A) that BDO be recommend as Auditor for 2017-2018 fiscal year. CARRIED. 	<p>office costs were inexpensive as staff were working out of their homes for a period of time before a new office location was secured.</p> <p>Wilf commented that more detail is required in the reports. For example, he referred to the Salary & Benefits figure \$100,770.00 and felt that a more detailed breakdown is needed to understand the particulars. In addition, he noted that it appeared that most of the money was going to salaries (out of the \$110,000.00 grant from MTCS). Ellen explained that OSGA had also received an Ontario Trillium Fund grant in that same year that also would have had a salary allotment. Gail Prior (29) also explained that reporting of numbers in a review engagement is meant to capture overall summaries of activity. Districts can always contact OSGA at any time to review details of any records.</p> <p>Petra Halk (21) needed clarification that the “annual conference” and the AGM were one and the same. It was also explained that “cash held for Districts” was a separate account for inactive Districts and could also be situations where OSGA holds grants for Districts.</p> <p>Ken Simard (1) Inquired whether Districts received interest on those “cash held “ accounts. Ellen explained that they do not.</p> <p>Tom Witzel (21) had a question on the statement that “affiliation fees were up due to a Provincial Year” . Ellen clarified that the financial report covered the period 2016/ 2017 so would have included the Midland and Cobourg (Summer/ Winter Provincial Games).</p>
8.	Proposed Bylaws - Gail Prior – Proposed Bylaws received by all Delegates.
	<p>Background: The last OSGA bylaw change was in 2003. OSGA Policies are being updated and added each year. These are posted on the OSGA website. OSGA Bylaws are under Industry Canada and abide by the National Not for Profit Act. Through recent discussions it was found that Constitution language was not required in our Bylaws therefore those sections were deleted.</p> <p>Gail suggested that the proposed Bylaws be reviewed and discussed on an Article by Article basis.</p> <p>Article I Definitions</p> <p>Motion: by Carol Lovelady (10), seconded by Marlene Neal (8) that Article 1 be approved. CARRIED</p> <p>Discussion and Questions:</p> <p>Irene Churchill (8) Director and Officer . Are they the same thing?</p> <p>Steve Indig: Provided clarification on Officers. There is no requirement to be a Director; some discretion allowed; can be elected or appointed.</p> <p>Article II – Membership</p> <p>Motion: by Roger Wallis (17), seconded by Nickie Sloan (2A) that Article II be approved (with change to 2.8 to allow for more flexibility). CARRIED</p>

Discussion and Questions:

Mitch Lupa (30) Question on age of 18 as a minimum age for a Delegate.

Gail Prior – Age was arbitrary . Noted that people under 55 cannot participate in events. A District could have a District Coordinator who is under 55.

Gary Chaput (7). Do those people under 55 have to pay a membership. Under 55 do not have to pay but must sign a volunteer agreement.

Article IV – Governance

Gail Prior – Currently we have 4 Executive Officers (President, Vice President, Treasurer, Secretary, 6 Directors, 2 Directors at Large.

Suggesting: Five to seven Directors (remove at large).

Irene Churchill – How do you have a non-voting person on the Board?

Gail Prior – There are various ways that Boards run their organization.

Steve Indig – new Act in 2014 . Provincial Act allows for an ex-officio position on the Board. The Federal Act does not allow an ex-officio position on the Board; need a fixed number of Directors; can invite a Past President to any meeting; why would someone want to be on a Board with no voting privileges?

Ellen Paterson (27) Can write-up a Policy for Past President to attend for a limited amount of time.

Gary Chaput (7) What is the legality of not following rules on Directors etc ?

Steve Indig . There have been limited lawsuits. There is a legal requirement to file Board information with Corporations Canada.

Ray Dahl (31) The majority of committees that he has been on , the Past President has been a “guidance councillor” type position.

Motion: by Jim Murphy (9), seconded by Carol Lovelady (10) to remove all references to Directors and Officers and replace with Directors. CARRIED

Motion: by Ellen Paterson (27), seconded by Marlene Neal (8) that the members will fix the number of Directors to be elected. CARRIED

The Past President would not have a vote. “ . CARRIED

Article VI and Article VII Committees and Conflict of Interest

Motion: by Carol Lovelady (10), seconded by Nickie Sloan (2A) to accept Article VI and Article VII with minor changes. CARRIED

Article VIII Finance and Management

Motion: by Shirley Barnes (13), seconded by Vanna Chiem (19) to accept Article VIII . CARRIED

Articles IX to XIV.

Roger Wallis (17) re: Article 12.1 .Why wouldn't District funds go back to the District upon dissolution of the Corporation.

Gail explained that the OSGA would no longer be functioning and with no structure to deliver games, insurance etc.

Re: Article 13.1 Will Indemnify . What about indemnification for Districts? Does this extend to Districts?

Gale Prior explained that this does extend to Districts and will clarify

CARRIED</p> <p>Mark Ling (5) Mark asked Steve Indig if OSGA was now in compliance with the National Not for Profit Incorporations Act with the proposed changes.</p> <p>Steve Indig replied that Yes we are in compliance based on what he has heard and with the changes that we are proposing to the OSGA bylaws.</p>
9	<p>Election of new Directors – Peter Hensel</p> <p>Motion: by Marlene Neal (8), seconded by Denis Ringuette (2) to fix the number of Directors on the OSGA to ten (10) . CARRIED</p> <p>Proposed Slate of Officers from Nominating Committee</p> <p>Still have one year left on their term:</p> <p>Treasurer Ellen Paterson Secretary Don Hector</p> <p>Board Members Denis Ringuette Gary Churchill</p> <p>Nominations were to be in by October 1, 2016 by our policy so we get a wide distribution of board members across the province.</p> <p>Four nominations were received.</p> <p>For President : Gary Churchill Angie Richard</p> <p>For Vice President: Gary Churchill, Lety Dudgeon</p> <p>Each new delegate was given the opportunity to speak outlining their background.</p> <p>An election process was held for each Position.</p> <p>Angie Richard was the successful candidate for President]</p> <p>Gary Churchill was the successful candidate for Vice President.</p> <p>Motion: by Mitch Lupa (30), seconded by Irene Churchill (5) to destroy the Ballots . CARRIED</p> <p>Peter Hensel explained at this point that we currently had 5 approved Directors on the Board. Peter asked to forward names of interested candidates to Peter Hensel or Geoff Johnson.</p> <p>Steve Indig advised that we need to elect Board members now as rules will only allow one appointment for every 3 Directors elected. These elections can only be done at a general membership meeting and unless OSGA wanted to call another General Meeting , they would need to wait until the next AGM to conduct elections.</p> <p>Motion: by Vanna Chiem (19), seconded by May de Jongh (19) to nominate Wilf Navarrete (15) as a Director . 10	<p>Other Reports</p> <p>Rules Committee – Peter Hensel. (Handout provided in the delegates information package)</p> <p>Peter provide an overview of Rule Changes for the coming year and rules under consideration</p> <p>Petra Halk (21) had a question on the ‘no charting’ rules in Floor Shuffleboard. Peter Hensel explained that charting is keeping notes of tracking of the disc on each shot / each court to improve their understanding of disc movement. This tends to slow the game down.</p> <p>Marlene Neal (D8) asked why there was a breakdown into 3 divisions. The rules still talk about 24 teams. Peter Hensel explained that there were variations in ice conditions in each curling rink and teams were at a disadvantage if they had to move to other curling rinks. Under the 3 division change, each Division could play their entire game series at one Curling Venue.</p> <p>Irene Churchill (D5) was concerned that only 8 Districts could apply to any one division where formally 24 opportunities were available.</p> <p>Peter Hensel explained that Bowling may be moving as a sole Summer Provincial Event.</p> <p>Dave Cave (7) inquired whether it would be 5 pin or 10 pin in the Summer Provincial Games or both. Peter Hensel explained that it was up to the host District to determine the bowling events that they would host.</p> <p>There was a discussion of “Caps” or the number of total participants allowed for the Winter and Summer Provincial Events. With the movement of bowling to the Summer Game option there would be a need to keep some events in the Winter Provincial Events to provide opportunities for competitors.</p> <p>Linda Spadaro (13) asked whether Table Tennis competitors could play both Doubles and Singles. This is still under consideration.</p>
